Supermax Corp

Not spared by Covid-19

- SUCB announced a temporary halt in operations at its production facilities in Meru, Klang, for three days due to the detection of positive Covid-19 cases.
- We estimate that SUCB's six plants in Meru, Klang, account for c.50% of its total capacity of 26.2bn pieces p.a.
- We estimate that the 3-day closure could impact FY6/21F net profit by -0.4%.

SUCB temporarily halts operations at all its factories in Meru, Klang

- In a Bursa announcement yesterday, Supermax (SUCB) announced that it will implement a temporary stoppage for three days (10-12 Feb) at its manufacturing facilities in Meru, Klang. This is in line with guidance from the Ministry of Health post the discovery of several positive cases of Covid-19 infection among SUCB's factory workers.
- We understand that SUCB has adopted stringent standard operating procedures (SOPs) to combat Covid-19 since 1Q20 and this is the first time it recorded positive Covid-19 cases; it suspects the infection spread to its workers through third-party transporters.

Six plants contribute up to 50% of SUCB's total capacity

- SUCB has a total of 12 factories, six of which are in the Meru, Klang area. In our estimates, the six factories account for some 50% of its total current production capacity of 26.2bn pieces p.a.
- Meanwhile, its operations in other locations – i) Sungai Buloh, Selangor, ii) Melaka and iii) Perak – will not be affected. They will continue to operate as normal
- Our channel checks found that, as of yesterday, less than 3.5% of SUCB's total estimated workforce of 3,300 tested positive for Covid-19. We understand that most of the workers who tested positive were asymptomatic; only six showed any Covid-19 symptoms and they have been hospitalised.

Will continue to implement stringent Covid-19 prevention measures

- We understand that all the SUCB workers who tested positive for Covid-19 worked at the same plant. However, SUCB decided to close all six plants in the Meru, Klang area to conduct deep sanitisation and disinfection activities.
- In addition, SUCB will continue to implement stringent precautionary measures and SOPs (in place since 1QCY20) to prevent the spread of Covid-19 among its workers. These include efforts such as: i) periodic Covid-19 screening for all its local and foreign workers, ii) social distancing measures, and iii) temperature checks.

FY21F net profit to be negatively impacted by 0.4%

- Assuming that all six of SUCB's plants in Meru, Klang, are not operational for only three days, we estimate that the impact on our FY21F net profit forecast will be -0.4%.
- Also, our sensitivity analysis indicates that should the six plants be non-operational for one week, our FY21F net profit estimate for SUCB will be reduced by 1%.

Retain Add

- We keep our FY21-23F EPS estimates, pending further updates on this matter. We also retain our Add call and TP of RM11.80, based on 15x CY22F P/E (in line with the glove sector's 5-year mean P/E). We continue to view SUCB as an attractive play, backed by: i) strong global glove demand owing to Covid-19, ii) its higher-than-average margins in the sector (due to its original brand manufacturing model), and iii) its solid dividend yields of 3.8-10.6% for FY21-23F.
- Potential re-rating catalysts: higher-than-expected rise in ASPs and faster-than-expected commissioning of new capacity. Downside risks: i) a sharp decline in ASPs, ii) higher-than-expected positive Covid-19 cases among its workers, and iii) a sharp decline in global glove demand.

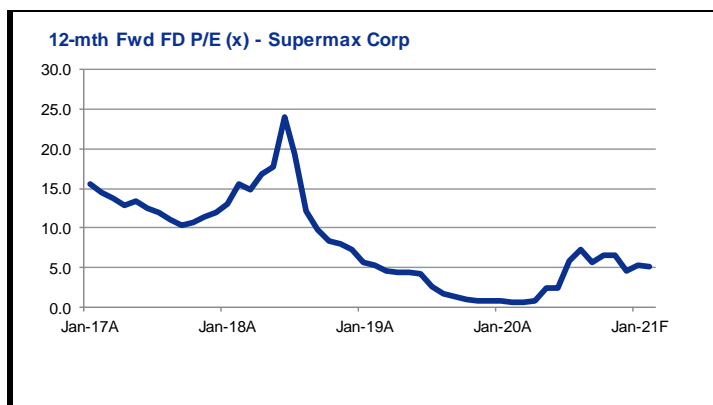

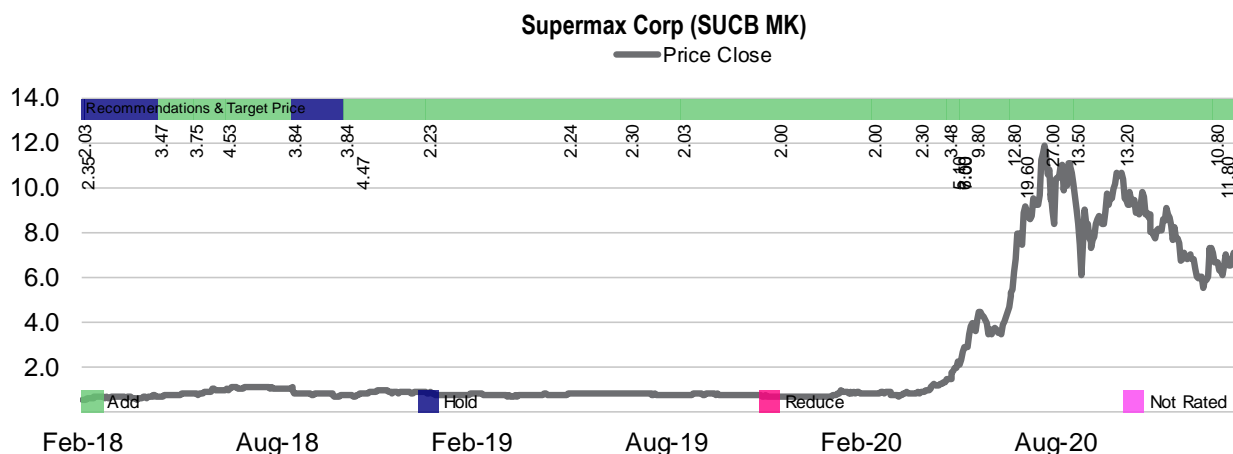

Definition:

- Overweight** An Overweight rating means investors should be positioned with an above-market weight in this country relative to benchmark.
- Neutral** A Neutral rating means investors should be positioned with a neutral weight in this country relative to benchmark.
- Underweight** An Underweight rating means investors should be positioned with a below-market weight in this country relative to benchmark.
